A. B. Schedule of Public Auction

The public bidding shall be conducted on "as is, where is" basis by the Philippine Consulate General Dubai's Property Disposal Committee from 9 November to 21 November 2021; 12:00 NN. The schedule for the opening of bids is set on 21 November 2021, 2:00 PM at the Rizal Conference Room of the Philippine Consulate General in Dubai.

C. Qualifications of Bidders

Individuals, partnerships and/or corporations are qualified to participate in the public auction, subject to the submission of qualified documents, as may be required by the Disposal Committee. Employees of the Philippine Consulate General are not qualified to submit bids.

D. Minimum Bid

In accordance with accounting and auditing rules and regulations of the Department of Foreign Affairs, the minimum bid for the sale of the used motor vehicle, Mercedes Benz E350, is set at Eight Thousand Two Hundred Eighteen Dirhams and Fifty-Five Fils (AED 8,218.55).

E. Submission of Bids and Bid Bonds
